JOURNEY FEST WEEKEND WILL FEATURE THE CHARLIE DANIELS BAND

BROOKSVILLE, FL. - JOURNEY FEST, scheduled for February 26 – 28, 2010 brings to Hernando County a three-day musical event showcasing over thirty-five bands on multiple stages throughout the grounds of the Sertoma Youth Ranch in Brooksville. Headlining the weekend event will be *THE CHARLIE DANIELS BAND*.

Some today's best Country, Southern Rock, Gospel and Christian artists will perform a full lineup of music for Journey Fest 2010. Saturday, February 27, will feature a complete day of family-oriented entertainment, including a Kids' Play Zone. A full array of food and craft vendors will be on hand, and other children's and family activities will make this a great family weekend. Closing out the festival on Sunday will be the performance by *The Charlie Daniels Band*.

During a fifty-year career, Charlie Daniels has topped charts in Rock, Country, Pop and Christian, and garnered countless awards from the Country Music Association,

Academy of Country Music, the TNN/Music City News Awards, and the Gospel Music Association. His signature song, “The Devil Went Down to Georgia” topped both country and pop charts, and brought international acclaim.

The Sertoma Youth Ranch, 85 Myers Road, Brooksville, is located between I-75 and the Suncoast Parkway, and is also easily accessible from State Road 50 (Cortez Blvd.) via Lockhart Road or Spring Lake Highway (CR 541) in Hernando County. Individual one-day tickets for Friday’s shows are \$10.00 per person; Saturday one-day, all performances are \$15.00 per person, and Sunday one-day for all shows, including the performance by The Charlie Daniels Band, are \$20.00 per person. Full weekend tickets are \$40.00 per person.
